

## Financial Aid for Summer Sessions

### Financial Aid Eligibility

Alexandria Technical & Community College financial aid award year consists of 1) fall semester, 2) spring semester, and 3) summer semester.

Summer semester financial aid eligibility is based on the amount of unused financial aid after fall and spring semesters.

### **Summer Financial Aid Application – Please complete and turn into the Financial Aid Office**

#### Continuing ATCC Students

If you have been attending ATCC and received an award letter for fall and spring semesters for the current award year, you will receive a summer award letter mid April after you have registered for summer semester courses and submitted a Summer Financial Aid Application prior to April 15, 2014.

If you register for courses after April 15, the Financial Aid Office will need approximately one week after you register and receive a Summer Financial Aid Application to send an award letter. You will receive an award letter via mail and an e-mail notice will be sent to you to view your award letter on eServices.

#### New ATCC Students

If you are a new student at ATCC starting summer semester, you must be accepted into your program for summer semester to receive aid. If you are accepted to begin your program beginning fall semester, you are not eligible for aid prior to the start of that semester.

- **Students registered for summer 2014 must complete the 2013-2014 FAFSA**
- **Students registered for fall 2014 must complete the 2014-2015 FAFSA**
  - Use school code (005544) on either FAFSA

There are many variables to determining aid eligibility for summer semester. You should never assume you have aid available for summer. Please let the staff in the Financial Aid Office assist you in determining your summer aid eligibility.
