## CERTIFICATION TRAINING

Safety inspections are required for commercial vehicles and farm vehicles (hauling placarded amounts of hazardous materials) over 26,000 lbs GVW (gross vehicle weight). Training provided in this class by the Minnesota State Patrol will prepare individuals to become certified as inspectors for trucks (including farm trucks), buses, and other vehicles required to have annual safety inspections.
