Basic Life Support (BLS) CPR for Healthcare Providers

The American Heart Association (AHA) designed the BLS Course to teach healthcare professionals how to perform high-quality CPR individually or as part of a team. BLS skills are applicable to any healthcare setting. BLS students will learn rescue techniques for adults, children, and infants. **This course is often required for entrance into academic nursing programs.**

Healthcare Providers

Heartsaver First Aid & CPR AED

Heartsaver courses are designed for anyone with little or no medical training who needs a course completion card for job, regulatory (for example, OSHA), or other requirements. These courses can also be taken by anyone who wants to be prepared for an emergency in any setting. Includes pediatric first aid. CPR covers adult, child, and infant CPR techniques and treatment of obstructed airways.
